## **Anti-Crisis (COVID-19) Solution**

### **Canada Emergency Wage Subsidy**

#### **Eligibility Criteria**

Individuals, partnerships, private corporations and Canadian non-profits and charities who are experiencing a 30% or more (15% or more in March 2019) decline in revenues due to the COVID crisis. Revenues will be compared monthly for March, April, and May 2020 for the same time in 2019, or to the average of January and February 2020 revenue. Employers must attest you are doing everything you can to meet the 25% amount.

#### **Amount**

75% of wage subsidies up to \$847 per week per employee

#### **Timing**

Payments will be made within 6 weeks

#### **How to Apply?**

Applicants need to re-apply monthly. Application forms will be available on CRA website, **My Business Account** section.

### **Work Share Agreement**

The program allows you to reduce employee working hours and remuneration by up to 50%, while the Employment Insurance pays a portion of the balance. The work share may be in place for up to 76 weeks.

### **Business Credit Availability Program (BCAP) Loan**

It is a credit facility that will be provided by the financial institutions and crown corporations to the creditworthy Canadian companies. It is an interest-based loan focused on maintaining your cash flow. The maximum amount of loan is \$6.25 million per applicant (of which up to \$5 million is provided by the crown corporation) with flexible terms and payment postponements for up to 6 months.

### **Business Credit Availability Program (BCAP) Guarantee**

It is a guarantee on your operating line of credit or term loan of up to \$6.25 million. The program is offered by the traditional financial institution and credit unions in conjunction with one of the crown corporations.



### **Canada Emergency Business Account**

It will provide interest-free loans of up to \$40,000 to small businesses and not-for-profits, to help cover their operating costs during a period where their revenues have been temporarily reduced. The loan will be provided by the traditional financial institutions in cooperation with the crown corporations. To qualify, these organizations will need to demonstrate they paid between \$20,000 to \$1 million in total payroll in 2019. Repaying the balance of the loan on or before Dec. 31, 2022, will result in loan forgiveness of 25% (up to \$10,000).

### **Canada Emergency Commercial Rent Assistance (CECRA)**

The program will seek to provide loans, including forgivable loans, to commercial property owners who in turn will lower or forgo the rent of small businesses for the months of April (retroactive), May, and June. Implementation of the program will require a partnership between the federal government and provincial and territorial governments, which are responsible for property owner-tenant relationships. More details to follow.

### **Regional Opportunities Investment Tax Credit in Ontario**

#### **Eligibility Criteria**

Canadian-controlled private corporation that makes qualifying investments that become available for use on or after March 25, 2020, in specified regions of Ontario. The tax credit would be available for expenditures in excess of \$50,000 and up to a limit of \$500,000. The tax credit would be available only in Northern Ontario and large parts of Southwestern and Eastern Ontario with the exception of Greater Toronto and Greater Ottawa areas.

#### **Eligible Investments (Expenses)**

Constructing, renovating or acquiring eligible commercial, industrial and certain farm buildings.

#### **Amount**

10% of eligible expenses reduce corporate income tax.

#### **Timing**

To be confirmed.

#### **How to Apply**

To be confirmed. Apply for tax credits at the end of your fiscal year.



## **Make Products or Develop Technologies to Fight COVID-19**

Respond to the government calls for proposal to make products, deliver services and develop technologies to help fight COVID-19.

- Government of Canada **call for proposals**
- Ontario Government **call for proposals**
- Advanced Manufacturing Supercluster **call for proposals**. The Supercluster **provides up to 100% of the eligible cost to**
  - support companies looking to develop and manufacture new therapeutics, equipment and products essential for COVID-19 response;
  - support manufacturers who currently produce essential equipment and products increase product output; and,
  - support manufacturers transitioning from the production of existing products to products essential for COVID-19 response.



## **Purchase or Upgrade of Equipment, Productivity Improvement**

### **Business Development Support Program (NL)**

#### **Eligibility Criteria**

- Be a small and medium-sized enterprise (SME) based and operating in Newfoundland and Labrador having fewer than 100 employees and less than \$10 million in sales.
- Demonstrate its ability to undertake the work identified in the project proposal.
- Demonstrate its ability to access the financial capital required to complete the project.
- Operate in a strategic sector as defined by TCII.
- Be in good standing with the Government of Newfoundland and Labrador.

#### **Eligible Cost**

- Land and Improvements
- Building and Structures
- Machinery and Equipment
- Leasehold Improvements
- Other Capital Costs
- Marketing
- Working Capital
- Wages and MERC
- Training
- Travel
- Professional/Technical Assistance

#### **Amount**

Up to \$100,000 per government fiscal year. Additional \$500,000 may be available in a form of 3%-interest government loan via Business Investment Program.

### **Productivity and Innovation Voucher Program (NS)**

The program lets businesses seek out expertise within post-secondary institutions to:

- Improve productivity;
- Develop a new product, service, or process; and
- Create growth.

#### **Amount**

Up to \$25,000.



## **Innovation Rebate Program (NS)**

### **Eligibility Criteria**

- Be a taxable Canadian corporation
- Have a permanent establishment in Nova Scotia and be in operation for a period of at least 12-months, or a planned permanent establishment in the province
- Be engaged in its primary business activity in the following industries:
  - advanced manufacturing and processing;
  - development of non-traditional sources of energy;
  - life-sciences;
  - aerospace and defence;
  - information and communication technology (ICT);
  - ocean technology; and
  - professional, scientific, and technical services excluding the following: legal services; accounting; tax preparation; bookkeeping and payroll services; advertising and related services; photographic services; veterinary services; translation and interpretation services.
- Demonstrate, to the satisfaction of Nova Scotia Business Inc. (NSBI), that it is financially viable and has reasonable prospects for continued growth and success.

### **Eligible Cost**

- Implementation of new or significantly improved production processes or waste stream processing;
- Investment in production capacity to enter new markets and/or produce new products;
- Establishment of new production facilities in Nova Scotia.

The costs can include:

- Direct costs of advanced machinery, equipment, clean technology, software, and hardware, including associated transportation and commissioning costs;
- Used equipment costs (if applicable)
- New building or building alterations related to the commissioning of equipment or implementation of business process improvements to a maximum of 25% of total Eligible Project Costs;
- Consulting, engineering, and subcontracting expenses directly related to the Eligible Project;
- Company incurred labour and wage costs for work performed directly on the Eligible Project; and
- Cost of industry or product certifications required for entry into new markets

### **Amount**

25% of eligible cost up to a maximum of \$3,750,000 over a 24-month period.



## **Business Development Program – Improving Competitiveness**

### **Eligibility Criteria**

- Be private-sector business;
- Demonstrate economic benefits for Atlantic Canada;
- Have adequate financing for the duration of the project;
- Be incremental;

### **Eligible Cost**

Cost of Development and Implementation of the following plans.

- Marketing Plan
- Human Resource Plan
- Productivity plan,
- Quality improvement plan
- Environmental management system
- Business plan or feasibility study,
- Investigate licensing opportunities,
- Conduct a venture capital search,
- Conduct technology transfer search,
- Provide mentoring services to improve your business skills
- Improve your ability to bid on and/or acquire public or private-sector procurement contracts or sub-contracts

### **Amount**

Up to 75% of eligible cost up.

## **Steel and Aluminum Initiative (Temporarily Unavailable)**

### **Eligibility Criteria**

- For-profit firms or Indigenous organizations, located in Atlantic Canada, that employ between 10 to 499 individuals on a full-time basis in Canada.
- Intensive users of steel or aluminum that can demonstrate plans for projects to enhance productivity or to increase competitiveness by adopting new innovative technologies.

### **Eligible Cost**

- Bolster the productivity and competitiveness of SMEs operating within the Canadian steel and aluminum supply chain through investments in innovative projects.



- Productivity improvement through acquiring, adapting, adopting new technologies, and/or processes; process re-engineering; and/or improving manufacturing capacity.
- Business scale-up through market development/expansion; diagnostics; adopting best management practices, processes and systems; and/or business opportunity development.
- Technology commercialization such as late-stage product development geared toward market diversification and growth, such as technology showcasing and technology demonstration.

### **Amount**

Non-repayable contributions from \$150,000 up to \$1 million, to support up to a maximum of 45 percent of eligible project costs. Priority will be given to projects submitted before April 8, 2019.

## **Productivity Improvement Assistance (PEI)**

### **Eligibility Criteria**

- Be a small business located in PEI.
- Have a well-developed business and marketing plan
- Manufacture, process, or provide exportable services in one of the following sectors:
  - food development
  - manufacturing
  - information and communication technology
  - bioscience
  - First-of-its-kind exportable services in other sectors may be considered.

### **Eligible Cost**

- Engaging professional expertise to develop and implement a productivity improvement plan
- Expanding industry knowledge through networking events and seminars (conditions may apply)
- Developing and implementing customized education, training and lean programs that will improve productivity for your company

### **Amount**

40% of eligible cost up to a maximum of \$16,000



## **Equipment Purchase and/or Renovations Assistance (PEI)**

The Capital Acquisition Support provides financial help to Prince Edward Island businesses in getting the infrastructure needed from start-up to international exporting. Through this program, business and government work together at those times when the business is most exposed to financial risk. Government will provide financial help during the start-up period and during growth of product lines or production of new products.

### **Eligibility Criteria**

- Be a small business located in PEI.
- Have well-developed business and marketing plan
- Manufacture, process, or provide exportable services

### **Eligible Cost**

- Cost of machinery and equipment
- Leasehold improvements, renovations

### **Amount**

25% of eligible cost up to a maximum of \$40,000

## **Climate Action Incentive Fund (CAIF) (Temporarily Unavailable)**

### **Eligibility Criteria**

- Be a for-profit company in Ontario, New Brunswick, Saskatchewan or Manitoba;
- Have less than 500 full-time equivalent (FTE) employees;
- Intend to significantly reduce direct and indirect greenhouse gas emissions.



## **Eligible Cost**

### **Direct Expenditures**

1. all capital costs, including site preparation, only once ECCC is satisfied that the Government of Canada's obligations, if any, related to the Canadian Environmental Assessment Act, 2012 and the legal duty to consult with, and accommodate, Indigenous Peoples have been met;
2. costs of acquiring, installing, rehabilitation and improvement of assets (e.g. site preparation);
3. costs of material and supplies, and their installation;

### **Contracted services**

1. professional or specialized services needed to undertake eligible project activities and for which contracts are entered into, such as accounting, communications, official languages translation, audit, energy savings estimate verification, and results monitoring, measuring and reporting;
2. costs of planning and assessment, such as surveying, engineering, architectural supervision, testing, and management consulting services. The Government of Canada will only contribute up to a maximum of 5% of its total contribution to the project towards these costs;
3. costs of performing activities related to the project by contractors;
4. costs of contracted work related to compliance with the Canadian Environmental Assessment Act, 2012 including engineering and environmental reviews, costs related to an environmental assessment and the costs of mitigation measures, follow-up, and remedial activities identified in any environmental assessment;

### **Salaries/ Benefits**

1. the incremental costs of the applicant's employees may be included as eligible expenditures. Canada will only contribute up to a maximum of 2% of its total contribution to the project towards these costs provided that:
  - A. the applicant is able to demonstrate that it is not economically feasible to tender a contract and clearly demonstrate that there is value for money in using internal employees;
  - B. the employee is engaged directly in respect of the work that would have been the subject of the contract; and
  - C. the arrangement is approved in advance and in writing by the Government of Canada.

### **Other direct project costs**

1. licenses and permits;
2. leasing and/or purchase of equipment related to the project;
3. training costs related to new technologies, equipment, software and systems;



4. costs related to the consultation of Indigenous Peoples, specifically project-related consultation activities arising as a result of the Government of Canada's legal duty to consult, where applicable;
5. costs directly associated with joint federal communication activities (e.g. press releases, press conferences, translation) and with project signage related to funding recognition;
6. travel expenditures (including the cost of accommodations, vehicle rental and kilometric rates, bus, train, airplane or taxi fares, allowances for meals and incidentals). The Government of Canada will only contribute up to a maximum of 5% of its total contribution to the project towards these costs. Of note, travel and per diem expenses cannot be more than the rates and allowances determined in the Travel Directive of the National Joint Council; and
7. provincial sales tax, goods and services tax, or harmonized sales tax for which the applicant or a third party is not eligible for a rebate, and any other costs that are ineligible for rebates.

## **Eligible Projects**

### **Agricultural retrofits**

- Changes to agricultural processes to improve energy efficiency
- Fuel switching to lower emitting energy sources in agricultural operations
- Other energy efficiency measures in the agricultural sector

### **Building retrofits**

- Enhancements to building envelope (with direct energy savings), including energy efficient windows/doors/skylights, increased insulation, weatherproofing, and glazing
- Energy efficient lighting system
- Heating, ventilation, and air conditioning (HVAC) equipment/systems/controls
- Water heating retrofits, including high efficiency condensing water heating
- High efficiency motors and controls
- Energy management controls, including building automation systems
- Fuel switching to lower emitting energy sources in existing buildings

### **Electricity, energy or fuel production**

- District energy (heating and/or cooling)
- Combined heat and power for own use\*
- Renewable energy systems (e.g. solar photovoltaic, wind energy, micro-hydro, stand-alone storage systems) on-site and for own-use\*
- Low-emission fuel production for own-use\*

### **Industrial process improvements**

- Retrofitting and upgrading of existing equipment used for industrial processes
- Fuel switching to lower emitting energy sources
- Process changes



- Waste-heat recovery

### **Transportation retrofits**

- Heavy-duty vehicle retrofits, including energy efficiency and/or fuel switching to lower emitting sources
- Marine vehicle retrofits, including energy efficiency and/or fuel switching to lower emitting sources

### **Waste**

- Energy efficiency measures in waste management

### **Amount**

\$250,000 per project (\$20,000 minimum)

## Skills Development and Training

### Canada- Newfoundland and Labrador Job Grant

#### Eligibility Criteria

- Be a for-profit business of any size and industry OR non-profit organization acting on behalf of employers (e.g. industry association, union)
- Be incorporated or a sole proprietor.)
- Have a Canada Revenue Agency business number.
- Be in good standing with Registry of Companies and Deeds.
- Have an office location/base in Newfoundland and Labrador.
- Current employee or Candidate is a Canadian citizen, permanent resident, or protected person under the Immigration and Refugee Protection Act (Canada) entitled to work in Canada. Temporary workers are not eligible.
- Training provider is a third party.

#### Eligible Cost

- Training (tuition) fees for the skills training that:
- Books & training supplies/materials
- Examination fees
- Travel cost
- Other mandatory training fees, if applicable
- It is up to the employer to select the training institution or educational service provider as long as the one provides a certificate or a record of the completion of the training.

#### Amount

The program provides 2/3 to 5/6 of the training cost up to a maximum of \$10,000 per trainee (\$15,000 if the trainee is an unemployed individual the company hires as a result of the training).

March 31, 2019

## **Workplace Innovation and Productivity Skills Incentive (Nova Scotia)**

### **Eligibility Criteria**

- Located in Nova Scotia
- Registered and active in the Nova Scotia Registry of Joint Stock Companies or incorporated by an Act of the Nova Scotia Legislature
- Over one calendar year into operations
- Generating directly or representing businesses (e.g. Sector councils) that have at least thirty percent (30%) of revenues from commercial activity\*
- Producing a minimum of \$25,000 in wages or owner remuneration
- Not solely generating profit from wholesale, retail, and accommodations and foodservices (e.g. businesses that manufacture and sell products).

### **Eligible Cost**

- Registration, tuition, course fees, or examination fees
- Manuals, books, and support materials
- Costs for accommodations for persons with disabilities (100%)
- Employee travel costs (up to 50%)

### **Amount**

The program provides 50% to 100% depending on the number of employees of the applicant up to a maximum of \$10,000 per trainee per fiscal year.

### **Deadline**

March 31, 2019

## **Workplace Skills Training (PEI)**

- Located in PEI
- Registered private sector businesses or Organization acting on behalf of a group of employers

### **Eligible Cost**

- Registration, tuition, course fees, or examination fees
- Manuals, books, and support materials
- Costs for accommodations for persons with disabilities
- Employee travel costs

### **Amount**

50% of eligible cost.

### **How to Get Started?**

## Export Sales, Marketing and Business Development

### CanExport Innovation (formerly Going Global Innovation)

#### Eligibility Criteria

- Be registered in Canada;
- Be an Innovator from one of the following Canadian organization types based in Canada:
- Small or Medium-sized Enterprises (SMEs);
- Academic institutions; and
- Non-government research centres.
- Have decision making authority over the technology.
- Have confirmed interest from a potential foreign collaborator – they know who you are, they know what your technology is AND they want to meet with you.
- Will be in a position to launch your technology into the global marketplace within the next 1-5 years.
- Own or co-own the intellectual property (IP) or the technology that will be commercialized;
- Demonstrate adequate managerial capabilities to execute the proposed activities and meet CanExport Innovation Recipient requirements;
- Have sufficient financial resources generated from private sources to cover their share of proposed CanExport Innovation activities;
- Not be funded entirely by Canadian government organizations (federal, provincial, territorial, municipal or Crown corporations);
- Be one of the parties performing the R&D work resulting from the Contractual Agreement(s);
- Demonstrate clear benefit to the Canadian economy should the proposed project be successful; and
- Applicants who have previously been approved and completed a CanExport Innovation Project must not have any outstanding documents still remaining to be submitted to CanExport Innovation. All reporting requirements for previous projects must be fulfilled in order to be considered for current CanExport Innovation funding.

#### Eligible Cost

- For activities requiring travel, CanExport Innovation determines the eligibility of travel expenses based on the following criteria:
  - Travel duration: Reasonable travel duration is determined based on the scope and complexity of the R&D collaboration. In general, a maximum of four days travel is supported. Exceptions may be approved with sufficient justification. For destinations that involve long overnight flights or which exceed five time zones, the CanExport Innovation travelers may arrive one full day prior to meetings.



- Number of participants: Only the travel costs of participants deemed as essential to formalizing the collaboration will be considered for CanExport Innovation funding. Travel expenses for individuals who are assessed as non-essential to the formalization of the R&D collaboration will not be funded.
- Costs: Funding of costs is allocated on a per person and or per date rate. Request for funding are assessed based on reasonability of estimated costs provided in the application submission. For certain expenses, reasonability of estimated costs is assessed against established CanExport Innovation guidelines. Those guidelines are detailed below in the description of each type of expenditure.
- Eligible expenditures are funded on a cost-sharing basis with CanExport Innovation supporting up to a maximum of 75 percent of the eligible expense type.
- Requested funding for eligible expenditures may be adjusted upon assessment based on current CanExport Innovation policies.
- Economy class airfare: Only the cost of lowest return economy class airfare for the straight route is eligible. For CanExport Innovation purposes, the straight route is defined as the route between the traveler's home location and the location of the approved CanExport Innovation activities, without any additional stops/legs/destinations for non-CanExport Innovation related purposes. For trips that include multiple activities and destinations that require additional air travel, only the cost of a multi-city lowest economy class airfare rate is eligible. A multi-city airfare rate must represent the travel route starting from the traveler's home location to the first approved location, travel route between the approved locations, and the travel route from the last approved location back to the traveler's home location.
- Accommodations: In determining reasonable accommodation rates, as a guide CanExport Innovation uses the Public Works and Government Services of Canada Accommodation Rates. Hospitality is ineligible for CanExport Innovation reimbursement and must not be included in accommodation estimates.
- Meals: CanExport Innovation allows for a daily per diem limit of CAD\$100 per day to cover the cost of meals on the dates of travel to the location of the approved CanExport Innovation activity; dates of the meetings and/or site visits; and the dates of travel back to the Applicant's home location.
- Local transportation: Reasonable local transportation in Canada and the foreign country, such as taxis, car rentals, public transportation, train in market, etc., are eligible expenses. All local transportation costs must be for the following purposes:
  - To and from airports;
  - To and from meetings; and,
  - To and from site visits.
- Legal fees: CanExport Innovation may provide a maximum of \$1,000 in CanExport Innovation funding (e.g. 75% of \$1,333 in legal fees) towards legal services to develop instruments necessary to formalize a contractual agreement for the R&D collaboration.



- Translation and interpretation costs: CanExport Innovation may provide a maximum of \$1,000 in CanExport Innovation funding (e.g. 75% of \$1,333 in expenses) towards translation and interpretation costs.
- Registration fees: CanExport Innovation supports project-driven activities and is not event-driven. Only in exceptional circumstances will CanExport Innovation support registration fees for a conference. If conference attendance is approved, only the lowest cost entrance fee to participate in the event is eligible.  
For registration fees to be considered eligible for consideration, Applicants must provide:
  - Sufficient evidence to justify why the meeting with the foreign partner cannot be held anywhere else or at any other time;
  - Evidence that cost of registration is for the lowest entrance fee rate. Booth fees are an ineligible expenditure.
- Photocopies or printed material: Photocopies or printed material includes informational materials used to inform the foreign partner of the applicant's capacity or technology. CanExport Innovation may provide a maximum of \$500 in CanExport Innovation funding (75% of \$666 in expenses) towards photocopies or printed materials. Printing costs of material not directly related to a CanExport Innovation funded activity are ineligible.
- Shipping of equipment: CanExport Innovation may provide a maximum of \$3,000 in CanExport Innovation funding (e.g. 75% of \$4,000 in expenses) towards expenses related to shipping equipment for the purposes of technology demonstration to the foreign partner. Shipping costs of material not directly related to a CanExport Innovation funded activity are ineligible.
- Meeting room rentals: CanExport Innovation provides support for reasonable meeting room costs. CanExport Innovation will consult with the Department's locally engaged staff to determine reasonability of estimated costs. Applicant may provide a quote outlining the meeting cost for a location near the partner's site as evidence of estimated costs.
- Audio/visual equipment rental: CanExport Innovation provides support for reasonable audio/visual equipment rental costs. Audio/visual equipment rental expenditures covered under Meeting room rentals are not eligible as separate expenses. CanExport Innovation will consult with locally engaged staff to determine reasonability of estimated costs. Applicant may provide a quote outlining the audio/visual equipment rental costs as evidence of estimated costs.
- Visas: Only expenses for single entry visas are eligible.

Activities that begin less than 8 weeks after submission date will not be reviewed and will be withdrawn from consideration immediately. The remainder of the application, independent of the withdrawn activities, must meet standard CanExport Innovation criteria.

In order to facilitate an 8 week processing time, applicants should provide immediate responses to any project-related inquiries from the Department. Delay in responding to inquiries may result in additional processing time. If requests for information have been unanswered by the applicant for 30 or more days, the application will be cancelled.
